- Represents shares acquired upon the release of RSUs, which convert into common stock on a one-for-one basis. These RSUs vest in four substantially equal annual installments commencing on February 10, 2022. This represents the 2024 installment.
- These performance-based RSUs were awarded on February 9, 2023 and vest in four substantially equal annual installments, commencing on February 9, 2024. This represents the actual number of RSUs awarded after the performance metric was certified.
